7. Treasury Report and Budget

a) Receiving and approving of the Treasurers 2017/18 Report

- Any donations we receive that help with registration fees are recorded on the balance sheet that way any funds that are not used can roll over to the next season. When families use these finds, they are drawn down from the balance sheet amount and move over to the registration fees revenue to help pay for their registration costs.
- All of the GS tournaments had a profit of \$14 000. Thanks to everyone in the association for all of their hard work and for going out and to get sponsors for these tournaments.
- We are still waiting for one ice rental invoice to come in
- At the bottom of your sheet you will see a breakdown of the average cost/player for the season and the total was around \$605/player

Jack asked about the March bill. All paid except for one tournament in Meaford Margaret asked about Initiation hockey - it will continue to be free Matt suggested that we send posters into the schools to advertise.

b) 2018/19 Budget including registration fees discussion

- This budget includes a \$25.00 price increase for registration due to rising insurance costs.
- We are assuming there will be no pre-season hockey camp due to the fact that Thornbury may not be putting in their uce until October 1st.
- Donations and tournaments are uncertain, but it looks like we will be having tournaments next season, but for budgeting purposes we did not include these revenues
- There is currently a budget loss of \$2657.00
