**Operational Guideline for 2020 -2021 St Vincent Community Centre**

Access is not permitted to anyone presenting the following symptoms:

- Fever
  - New Onset of Cough
  - Worsening Chronic Cough
  - Shortness of Breath
  - Difficulty Breathing
  - Sore throat
  - Difficulty Swallowing
  - Decrease/Loss of Sense of Taste/Smell
  - Chills
  - Headaches
  - Unexplained Fatigue/Malaise/Muscle Aches
  - Nausea/Vomiting
  - Diarrhea
  - Abdominal Pain

- All organizations or user groups must fill out a “return to play” document. This document must be submitted to [jbedard@meaford.ca](mailto:jbedard@meaford.ca) and approved before granted access to a seasonal contract.
- All users will have to complete a prescreening for Covid -19 document that must be signed before they are able to use our facility. All documents must be returned to [jbedard@meaford.ca](mailto:jbedard@meaford.ca) no later than 2 days prior to your rental. Any new participants to your group must be reported and signed off before they will be granted entry to the facility. Anyone found participating that did not complete the prescreening document will be removed right away and will not be allowed back for the 2020/2021 season.
- All user groups or organization must keep a log of every player or attendee that uses the facility during their allotted time. Any participant that is involved in a league or organization at another facility, must acknowledge so.
- No renter/user will have access to the Community Center any time 15mins prior to their programs start.
- 2m markings will be marked outside the front entrance for standing locations. The organizer will be responsible for their groups 2m social distancing, when in and outside the facility.
- No more than 48 participants / users will be allowed in the ice/lobby section at one time.
- All renters must maintain 2m social distancing measures and must be wearing a facemask at all times before the rental begins. Mask will remain on until participants are on the ice.
- Front doors will remain locked until municipal staff allows access to the designated areas.(15mins prior)
- All front entrances will be signed with operation use and facility rules.
- Sanitizer stations will be available at all entrances and exits.
- Arrow signs on the floor will show users right of way direction.
- All participants / users will enter through the east side front doors and will exit through the west side front doors located at the front of the St Vincent Community Center.
- No fans or spectators will be allowed at this time. Exceptions will be made with minor groups such as Minor Hockey and Meaford figure skating.



- No pick up or shinny games will take place until social distancing measures have been removed or public health restriction are removed.
- League / organized hockey will be permitted as long as they do not allow prolonged or deliberate physical contact between players. The leagues or organization must have the same participants every week and or for a 14 day period.
- Children under 18 years of age can be accompanied by a parent. Parents must leave the facility immediately after dressing their child unless granted permission from the municipality of Meaford staff.
- Children under 18 years of age must come dressed with exception of skates, gloves and helmets
- Adult leagues will have permission to get full dressed in the dressing rooms.
- User groups will have access to the lobby or dressing rooms once they enter the facility. Staff will direct your group to your location.
- Dressing rooms will have 2m spacing in designated areas between all participants. Only six players per dressing room will be permitted. User groups will have access to 3 or 4 dressing rooms. No showers will be available. Participants will be asked to stay in dressing room until the Olympia has left the ice.
- Lobby area will have 2m spacing in designated areas between participants. No showers will be available. Players will be asked to stay in the lobby until the Olympia has left the ice.
- Organizations such as Georgian shores and Meaford figure skating, will be allowed to rent multi hour time blocks. This will only be permitted if the number of participants that enters the facility during that duration is less than 48.
- All dressing rooms will be cleaned/ disinfected after every use.
- Lobby washrooms will be limited to 1 person at a time.
- 30 minute time periods will be granted between each user for staff to effectively clean our facility. This will be subject to player's benches, nets, washrooms, dressing rooms, entrances and exits.
- No participant or user will be able to use the dance hall or meeting room to do any warm up. Warm ups must be done before entering the facility.
- All ice users are limited to NO more than 25 participants on the ice surface at one time. This includes, coaches or trainers
- No spitting or blowing of nose can take place without a cloth or Kleenex and must be disposed of right away.
- Benches are limited to 5 participants each. Each bench will have 2m social distancing markings in place. Participants will enter through the south side of the bench and exit through the north side of the bench.
- All users must bring their own training equipment. No equipment will be left on site.
- Main lobby will be limited to No more than 25 people at a time.
- Canteen services will be unavailable but water fill stations will be.
- Score clocks will be unavailable at this time.
- The public will not be permitted in the Olympia room.



- “No Loitering” will take full effect. Once the user group have left the ice they will have 15 mins to have left the inside of the facility. No alcohol will be permitted in the facility or on the property.
- Public Skating / stick & puck will not be permitted at this time.
- Each user group is expected to have one first aid kit on hand.
- Sticks will only be permitted inside dressing rooms and not left outside the doors.
